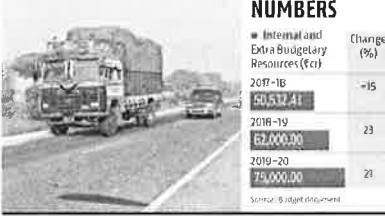
CAG red-flags highway costs

Says NHAI's borrowings are also government borrowings and should be accounted for accordingly

New Delhi, 29 August

The Comptroller and Auditor General of India (CAG) has sought a cost audit of national highway projects as it feels expenses are rather high. It has said the government should curtail its debt-raising measures.

According to an official in the know, the CAG has raised concerns over the burgeoning costs of the National Highway Authority of India's (NHAI) projects. It has alerted the Ministry of Finance, saying the NHAI's borrowings are also the government borrowings and should be accounted for accordingly.

In FY19, the NHAI raised ₹62,000 crore through a mix of debt from banks, toll revenue, and a road monetisation scheme. If the NHAI monetises its assets it would lead to a steady decline in its toll collection as the agency which undertakes the operation and maintenance of the projects will be getting the levy.

Financial stress of the NHAI had become a concern, with the Prime Minister's Office (PMO) recently stepping in with suggestions. The PMO asked the Ministry of Road Transport and Highways (the parent ministry of the NHAI) to improve its operational performance.

The PMO also suggested that the NHAI monetise its road assets base through toll-operate-transfer (TOT) auctions or through an infrastructure-investment trust (INVT). It asked the NHAI to bid out new projects under the build-operate-transfer (BOT) private owners build, own and maintain the road for a specified period of time before transferring the asset back to the government.

In the case of IAM, the central government bears 40 per cent of the project cost and the remaining amount is arranged by the developer.

The government has made fund allocation to the NHAI for major works under the Ministry of Road Transport and Highways, Bhubaneswar, entrusted to the organisation for execution this. The money will come from the Central Road Infrastructure Fund (CRIIF), Permanent Dividend Fee Fund (PDFF), and Monetisation of National Highways Fund (MANHF).

An official said requesting anonymity. Recently, Road Transport and Highways Minister Nitin Gadkari said, "The NHAI is a AAA rated organisation and we can raise enough debt to keep building roads. A senior NHAI official said, "We are repaying debt every year and we have taken cognizance of the suggestions of the PMO and will give our response to them."

Besides project monetization, the NHAI is also looking at reviving the BOT model of construction. Under the BOT, private owners build, own and maintain the road for a specified period of time before transferring the asset back to the government.

In the case of IAM, the central government bears 40 per cent of the project cost and the remaining amount is arranged by the developer.

YES Bank slumps 7% on rating downgrade

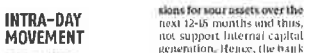
Moody's cuts rating by a couple of notches, from Ba1 to Ba3

Mumbai, 28 August

Credit rating agency Moody's on Wednesday downgraded private lender YES Bank's long-term foreign currency issuer rating by a couple of notches, from Ba1 to Ba3. It cited lower-than-expected capital raised by the bank recently and its ability to raise further capital, considering the huge hit the bank has taken in its share price.

The rating downgrade resulted in YES Bank's stock price going down further. The stock price tumbled more than 7 per cent to close at ₹59.50.

Moody's also downgraded YES Bank's long-term foreign and local currency bank deposit ratings to Ba3 from Ba1 and maintained a negative outlook on the bank's solvency, funding or liquidity, as the bank continues to work through the asset quality issues and rebuilds its



loss-absorbing buffers."

The private lender recently raised ₹1,930 crore via issuance of equity shares under the qualified institutional placement route. This moderately improved the bank's common equity tier 1 capital ratio as of 30 June 2019 to 16 per cent from 9 per cent, said Moody's.

YES Bank is looking to further raise capital to the tune of \$600 million.

Also, Moody's expects the bulk of the bank's operating profit to go into higher provisions for its assets over the next 12-18 months and thus, not support internal capital generation. Hence, the bank has to rely increasingly on external capital to improve its loss-absorbing buffers, which will become increasingly difficult, given the substantial decline in its share price.

In the quarter ended June 2019, YES Bank's gross non-performing assets (NPAs) stood at 5.01 per cent, against 4.31 per cent in the first quarter of 2019. In the March quarter, gross NPAs of the bank stood at 3.2 per cent.

About 41,000 crore of loans, or 4 per cent of YES Bank's total loans, remain on a watch list, meaning the bank expects the quantum of loans to translate into NPAs in the next two-three quarters.

Moody's, however, said it could change the rating outlook to stable if the private lender adequately provides for its bad assets and further raises capital to strengthen its loss-absorbing buffers.

Recommendation part of Trai's consultation paper on services offered by distribution platform owners

The telecom regulator released a consultation paper regarding services offered by distribution platform owners (DPOs), expressing a range of concerns raised by the Ministry of Information and Broadcasting through a letter it wrote in July.

Platform services (PS) channels are those that are provided by local cable operators or

direct-to-home (DTH) operators exclusively to their subscribers such as Tata Sky Active or Tata Sky World Screen.

The Telecom Regulatory Authority of India (Trai) has asked for comments on revision of the registration fees for PS channels. At present, broadcast operators pay a processing fee of ₹10,000 for registration of a channel in addition to a fee of ₹5 lakh per annum for the licence, and another ₹5 lakh per year in the form of permission fee to download channels. For channels not transmitted by DPOs from India, a broadcaster is supposed to pay ₹10 lakh per annum.

For PS channels, on the other hand, DPOs are required to pay a one-time registration fee of ₹3,000. Trai has, in its paper, asked if this fee should be increased to ₹1 lakh since the DTH landscape has changed significantly since the registration fee structure was laid down in 2014.



Other issues raised by the Trai range from placement of such channels on the electronic programming guide to the maximum number of channels a DPO should be allowed to carry.

The paper also asks if the onus of maintaining exclusivity should fall on DPOs. This means the cable or DTH operator has to ensure that the content being provided by them is not shared with other DPOs. Many DPOs, especially DTH service providers, carry a number of PS channels with content varying from infomercials to interactive services. While a lot of the content may be created for a DTH operator, many have movies-on-demand or pay-per-view services, and some titles do overlap from one DPO to another. Trai's paper argues that if such PS content were to be shared, it would be like any other regular TV channel. According to regulators, the DPOs are not allowed to include foreign TV channels not registered in India.

Also, according to the data provided to Trai, all four DTH providers - Tata Sky, Dish TV, Airtel DTH, and Sun Direct - are operating at

full capacity, with no bandwidth to spare for new channels. However, players like Dish TV and Tata Sky have 40 and 41 PS channels, respectively. The lack of a cap on the number of PS channels could lead to hindrance in "must carry" stipulation that applies to all DPOs. According to regulations, a distribution platform must carry a channel within 60 days of a receiving a written request from the broadcaster, or within 30 days of signing the agreement. However, at present, the "must carry" rule does not apply to DPOs to ensure they are required to carry must channels. "Almost all DTH operators have declined to spare capacity, whereas all have PS channels. Some have as many as 42, 25, and 20 such channels. Clearly, there is a need for regulating them," Trai said in the paper.

The Trai has called for comments from stakeholders by September 27.

The Comptroller and Auditor General of India (CAG) has sought a cost audit of national highway projects as its fees expenses are rather high. It said the government should curtail its debt-raising measures.

According to an official in the know, the CAG has raised concerns over the burgeoning costs of the National Highways Authority of India's (NHAI's) projects. It has alerted the Ministry of Finance, saying the NHAI's borrowings are also the government borrowings and should be accounted for accordingly.

Experts are of the opinion that the NHAI's debt situation is a cause of concern. It is expected to touch ₹2.5 trillion by the end of the current fiscal year (2019-20 or FY20). The payment obligation on account of interest is expected to be about ₹3,000 crore annually in the next two decades.

Major sources of income for the NHAI is toll revenue and grants from the government. Since last year, it has been monetising completed projects. About ₹8,000-9,000 crore will come from tolls. This is used for maintenance of highways.

The NHAI's borrowing target was raised 21 per cent in FY20; it can raise ₹78,000 crore. The government will

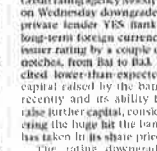

Credit rating agency Moody's on Wednesday downgraded private lender YES Bank's long-term foreign currency issuer rating by a couple of notches, from Ba1 to Ba3. It cited lower-than-expected capital raised by the bank recently and its ability to raise further capital, considering the huge hit the bank has taken to its share price.

The rating downgrade resulted in YES Bank's stock price going down further. The stock price tumbled more than 7 per cent to close at ₹50.50.

ISSUES ARISING OVER THE

The private lender recently raised ₹1,200 crore via issuance of equity shares under the qualified institutional placement route. This moderately improved the bank's common equity tier 1 capital ratio as of 30 June 2019 to 8.6 per cent, from 8 per cent, said Moody's.

Moody's also downgraded YES Bank's long-term foreign and local currency bank deposit ratings to Ba3, from Ba1, and maintained a negative outlook on the bank.

The negative outlook primarily reflects the risk of further value erosion to the bank's solvency, funding or liquidity, as the bank continues to work through the asset quality issues and rebuild its

loss-absorbing buffers, which will become increasingly difficult, given the substantial decline in its share price.

In the quarter ended June 2019, YES Bank's gross non-performing assets (NPAs) stood at 0.91 per cent, against 1.31 per cent in the first quarter of 2018-19. In the March quarter, gross NPAs of the bank stood at 8.2 per cent.

Moody's, however, said a credit change the rating-outlook to stable. The private lender adequately provides for its bad assets and further raises capital to strengthen its loss-absorbing buffers.

The telecom regulator released a consultation paper regarding services offered by distribution platform owners (DPOs), expressing a range of concerns raised by the Ministry of Information and Public Relations through a letter it wrote in July.

Platform services (PS) channels are those that are provided by third party operators or

direct-to-home (DTH) operators exclusively to their subscribers such as Tata Sky Active or Tata Sky World Screen.

The Telecom Regulatory Authority of India (Trai) has asked for comments on revision of the registration fees for PS channels. At present, broadcasters pay a processing fee of ₹10,000 for registration of a channel in addition to a fee of ₹5 lakh per annum for the licence, and another ₹5 lakh per year in the form of permission fee to download channels. For channels not transmitted (uploaded) from India, a broadcaster is supposed to pay ₹10 lakh per annum.

For PS channels, on the other hand, DPOs are required to pay a one-time registration fee of ₹10,000. Trai has, in its paper, asked if this fee should be increased to ₹1 lakh since the DTH landscape has changed significantly since the registration fee structure was laid down in 2014.



Other issues raised by the Trai range from placement of such channels on the electronic programming guide to the maximum number of channels a DPO should be allowed to carry.

The paper also asks if the costs of maintaining exclusively shielded land on DPOs. This means the cable or DTH operator has to ensure that the content being provided by them is not shared with other DPOs. Many DPOs, especially DTH service providers, carry a number of PS channels with content varying from documentaries to children's entertainment. In the content being provided by them is not shared with other regular TV channels. According to regulations, the DPOs are not allowed to include foreign TV channels not registered in India.

Also, according to the data provided to Trai, all four DTH providers — Tata Sky, Dish TV, Airtel DTH, and Sun Direct — are operating at

full capacity, with no bandwidth to spare for new channels. However, players like Dish TV and Tata Sky have about 40-45 PS channels, respectively. The lack of a cap on the number of PS channels could lead to hindrance in 'must carry' stipulation that applies to all DPOs.

According to regulations, a distribution platform must carry a channel within 60 days of receiving a written request from the broadcaster, in within 30 days of signing the agreement. However, at present, the 'must carry' rule does not apply if DPOs do not have spare capacity to carry more channels. Amidst all this, private players have declared to spare capacity, whereas all PS channels. Some have more as 42, 25, and 20 such channels. Clearly, there is a need for regulating them," Trai said in the paper.

The Trai called for comments from stakeholders by September 27.

The Supreme Court (SC) on Wednesday agreed to hear pleas filed by petitioners challenging the abrogation of Article 370 and said a five-judge Constitution Bench would start hearing the validity of the government's move from the first week of October.

Despite SC opposition, Attorney General K.K. Venugopal and Solicitor General Tushar Mehta, a three-judge bench, led by Chief Justice of India Nageswara Rao, issued notices to the Centre and the Jammu and Kashmir (JK) administration, and sought their responses on the petitions.

The issuance of notice by the apex court would mean that the case has been formally taken on board by the SC. AG Venugopal and SG Mehta, while opposing the same, said that the notices would have 'no-endorsement' character, which would be used by other countries, adding that whatever was said by the apex court was being taken to the United Nations by these countries.

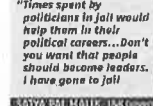

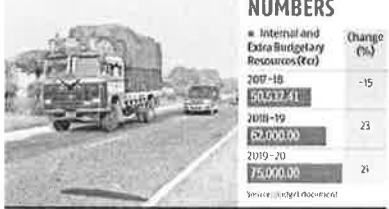

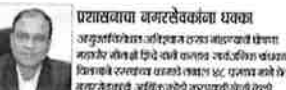
