आरक्षण नाहीच

अनुसूचित जमाती प्रवर्गातून आरक्षण मिळावे यासाठी गेली सात वर्षे धनगर समाज न्यायलयीन लढा देत होता. या सर्व याचिकांवर युक्तिवाद पूर्ण झाल्याने न्यायालयाने निकाल राखून ठेवला होता. अखेर न्या. गीतम पटेल आणि न्या. कमल खता यांच्या खंडपीठाने शुक्रवारी हा निकाल जाहीर केला. दिवसभर निकालाचे वाचन करत सायंकाळी धनगर समाजाची मागणी खंडपीठाने फेटाळून लावली.

याचिकाकत्यांतर्फे ॲड. अभिनव चंद्रचूड यांनी याविरोधात सर्वोच्च अपिल स्थगिती करण्यासाठी निकालाला देण्याची विनंती खंडपीठाला केली; मात्र खंडपीटाने त्यांची ही विनंती फेटाळून लावली. सात वर्षानंतर जाहीर होणारा निकाल जाणून घेण्यासाठी राज्यभरातून मोठ्या प्रमाणावर धनगर समाज न्यायालयात आले होते; परंतु याचिका फेटाळल्याने त्यांची घोर निराशा झाली.
